Narrative CV

As a demographer/sociologist by training, I have a broad orientation thematically. Outside of my core area of family and the life course, I list social stratification and migration as my secondary research areas and have contributed to methodological research. I am particularly interested in research that combines my primary and secondary fields: family on the one hand, and social stratification or migration on the other. I have published in prestigious journals in a diversity of subject areas: sociology (*American Sociological Review*), demography (*Demography*), family (*Journal of Marriage and Family*), social geography (*Population, Space and Place*), and gerontology (*Journal of Gerontology*).

My scientific work has always been combined with collecting new survey data and contributing to the community's data infrastructure. I have been a (co)leader of several large survey research enterprises, including Netherlands Kinship Panel Study (NKPS), Netherlands Longitudinal Lifecourse Study (NELLS), Children of Immigrants Longitudinal Survey in 4 European Countries (CILS4EU), and Parents and Children in the Netherlands (OKiN). All of these surveys consisted of the design, development and collection of large-scale survey data, typically in a team of senior scholars, postdocs, and PhD students. The last survey (OKiN) was a unique register-based multi-actor survey funded by an ERC grant. A team-written publication on this project was published in *American Sociological Review*. All the data sets are extensively documented and available for free in the public domain (i.e., open access via the DANS-KNAW data archive). During my ERC project on family complexity (divorce and

stepfamilies), there was extended outreach via newspapers, national radio and TV, popular research outlets, and workshops including policy makers and stakeholders.

When taking citations as an indicator, my research can be regarded as influential. I had an important substantive influence on the field of sociology and demography in two ways. First, I have been influential in the theoretical development of the field. My paper on intermarriage and assortative mating in the *Annual Review of Sociology* (1998) presented a theoretical framework for understanding partner and marriage choices that has been a leading perspective for most of the research that has since been published. I have presented similar theoretical syntheses for related problems, such as for the study of intergenerational relationships in a well-known handbook (The Wiley-Blackwell Companion to the Sociology of Families, 2014) and the link between divorce and inequality in the new forthcoming handbook on Social Stratification (Oxford University Press, forthcoming). Second, I have had an influence on the field through the (publicly available) surveys I developed. These projects led to numerous publications, also by people outside of the team. Moreover, these surveys have been an inspiration in Europe and have led to similar initiatives in Belgium (Divorce in Flanders) and Germany (The German Family Panel-PAIRFAM) which were funded by the national science foundations in the respective countries.

I supervised 19 PhD students and 7 Postdocs (including current projects). I tend to work closely with my PhD students in an informal atmosphere where an emphasis on scientific rigor and excellence is combined with an emphasis on respect, work-life balance, and job satisfaction. The composition of my PhD students has been diverse in terms of gender and national origins. In so far as possible, I organize my projects in teams where multiple PhD students participate and where people learn from each other. Some of my former students and postdocs have academic positions and a few have already achieved top positions in universities (Van Ingen, Van Tubergen, Poortman, Monden, Uunk). I collaborated with all of these scholars, also on new topics after supervision ended. Most of these scholars have continued doing work related to or building on earlier collaborations. I am proud that several of my bachelor and master students received an award for their thesis (e.g., Van den Bogaard, Zwiers) or had it published in a scientific journal (e.g., Van Huizen, Van Steensel, Spaan). Although I enjoy collaborating, I also keep writing articles on my own. Of the ISI publications in the last five years, 30% were solo-authored, 43% were with PhDs or Postdocs, and 27% were with other senior scholars.
